I confirm that, to the best of my knowledge any statements made by me during the Performance will be true and will not violate or infringe upon any third party's rights.

I agree that, at no cost to you, I have secured, or will secure (and/or will arrange with any respective publisher and/or third party owner to secure) all rights, including synchronization rights necessary for you to use any musical composition(s) contained in the Programming, but only with respect to composition(s) I own, control, wrote and/or co-wrote, in addition to any composition(s) I perform in connection with the Programming.
